Applications are hereby invited for temporary engagement of **4 (Four) Nos. Aspirational Block Fellows** for four Aspirational Blocks namely Jatinga Valley, Diyung Valley, New Sangbar and Diyungbra Development Block under the Aspirational Block Programme, Dima Hasao for a period of 12 months only.

1. The candidate must be a citizen of India.
2. Stipend: Monthly stipend of **Rs.55,000/- only**
3. Age Limit: Should not be less than 21 years and not more than 35 years as on 31st March 2023.
4. Eligibility Criteria & Required Skills:
 - i. Postgraduate in any discipline from a recognised reputed institution. Candidates having MSW Degree will be given preference.
 - ii. Should possess data analysis and presentation skills.
 - iii. Should be conversant with the use of social media.
 - iv. Should possess Project Management Skills.
 - v. Experience of working/internship with a Development Organisation.
 - vi. Self-driven with good communication skills.
 - vii. Knowing the local language of the respective Aspirational Block is a requirement for all Aspirational Block Fellows.
5. Desired Skills: Knowledge, Skill, Experience & Expected Performance
 - i. Prior experience in the Government/ private sector in the field of development sector and project management as National/State level Schemes or Projects is desirable.
 - ii. Collaboration with Block Level Officials to design and execute development strategies aligned with ABP thematic areas.
 - iii. Conducting regular field visits to assess project implementation, address challenges and collect ground-level insights.
 - iv. Analyzing data and providing evidence-based recommendations to BLOs, District Level Officials to optimize developmental initiatives.
 - v. Organising workshops, awareness campaigns and skill-building programs to empower the local community.
 - vi. Keeping the District Commissioner, Dima Hasao abreast with the issues, challenges and need for support.
 - vii. Provide assistance in the documentation of good governance practices.
 - viii. Use of the ABP portal to assess the performance of the blocks and communicate to all the Block Level Departmental Officials.
 - ix. To attend training programmes as conducted by NITI Aayog, State or District.
 - x. To send regular reports to the NITI Aayog, State and District.

- xi. To work under the overall guidance of DC/BDO of the District and report to the BDO for everyday functioning.
