MINUTES OF THE NCORD COMMITTEE MEETING HELD ON 05/06/2023 AT 11 A.M.IN THE CONFERENCE HALL OF THE OFFICE OF DEPUTY COMMISSIONER, DIMA HASAO

At the very outset Shri Srimanta Das ACS-Deputy Commissioner Dima Hasao cum chairman NCORD Committee Dima Hasao welcomed all members present in the meeting. Narcotic Control Board representative from Guwahati joined the meeting through electronic mode.

At the outset Superintendent of Police Dima Hasao explained the role and responsibility of the NCORD committee as defined by Ministry of Home Affairs.

EXCHANGE OF Intelligence:-The primary role of the committee would be the exchange of intelligence about possible drug trafficking, and in that case Police deptt. would be in the forefront. The role of forest department would be to share information about poppy and Morijuana cultivation in the remote areas of the District especially in interstate borders.

Education department should instruct the principals and school teachers to find out drug abuse amongst students and come up with information the department shall also arrange awareness campaigns in different areas and a special task force shall be constituted by the Principals of all high and Higher Secondary schools, and regular parents guardians meetings shall be organised for sensitization of parents/guardians. Principals shall also take steps in sensitizing students about ill effects of drug abuse. Education Department informed that awareness campaigns are already being organised in different educational institutions. Meeting also requested Inspector of Schools to appeal the Principal/Head Master of Schools to form "NO DRUG CLUB"in Schools. The Inspector of Schools shall also submit an action plan for combating drug abuse amongst students.

Superintendent of Police Dima Hasao informed that drug detection kits are presently not available at Dima Hasao for which Police Deptt have been using their intelligence network for detecting drug trafficking.

Health deptt. informed that presently there is no drug rehabilitation centre in Dima Hasao for which drug addicts have to be treated in the centre attached to Holy Spirit Hospital. Health department also informed that presently the District is running without a qualified psychiatrist in the district. Regarding scheduled 'H" Drugs, the District Magistrate Dima Hasao directed that the Health Deptt. should ensure that setting up of CC cameras in all chemist shops; The Health Deptt. official informed that CC Cameras have already been installed in all chemist shops.

Social Welfare Deptt. has been asked to constitute Mothers group in different areas for creating awareness amongst masses and organise awareness programmes. District Magistrate suggested to include Superintendent of Excise ,Haflong as one of the members of NCORD

He also directed that all Heads of offices should remain present in the NCORD meetings instead of sending their representatives.

After threadbare discussion, the meeting ended with vote of thanks from the chair.
