

Terms & Conditions :-

1. The Candidate must be a Citizen of India as defined in the Constitution of India.
2. The Candidate must not be less than 18 years and more than 40 years of age as on the date of application. The upper age is relaxable as per Govt.Rule.
3. **Minimum qualification is class VIII passed**. Candidates those who have passed H.S.S.L.C or above shall be **ineligible** to apply.
4. If any candidate is found to have suppressed his educational qualification or given any wrong information at the time of applying for the post, his candidature shall be liable to be rejected at any stage and may be prosecuted.
5. 
